Next there was an extensive discussion of the nominating and voting process itself, whether it should be electronic, or be by written ballot or voice vote at the January meeting. It was agreed that in addition to the slate, nominations should be open from the membership for a period of time as well. This lead to a discussion regarding the need to update the club's bylaws to conform them to changes in the club and its election process (e.g. the club does not hold a December meeting anymore).

The board approved a motion to revise the by-laws at this meeting for presentation to the membership at the general meeting during the holiday party on 11/22/14.

Prior to the meeting Bill Sellin had reviewed the bylaws and prepared drafts to be reviewed and discussed by the board. With Bill's help and knowledge of club history the board went through various sections of the bylaws line-by-line. The board focused on changes to the board nominations and election procedures, the timing of various steps and the updated regarding club communications.

After extensive discussion and editing, a final revision of the bylaws was completed. Upon a motion by Marc Urias, seconded by Jim Norman, the board approved the bylaws to be presented to the membership at the November general meeting. The membership vote on the changes will be held during the next general meeting in January 2015. A copy of the proposed changes is attached to and incorporated in these minutes.

A question came up as to whether or not the amended bylaws would need to be filed with the state. After the meeting Jim Norman researched this and confirmed that no filing is needed. Only changes to the Articles of Incorporation need to be filed with the Secretary of State.
