Reading of the Minutes

Director Reports

The treasurer's monthly report as of 9/30/17 is attached to these minutes; along with a report regarding the Gary Thomsen accident and related insurance items.

Steve reports the club has fulfilled its responsibilities regarding Gary Thomsen and our insurance carrier, and it is now Gary's family's responsibility to pursue payments from the insurer related to medical expenses and death benefits, if they so desire.

Steve will contact the club insurer to see if they can send us a "bullet list" to distribute to members explaining our coverages, what to do in an accident, and making claims.

Steve negotiated a price of \$327 for TidyHQ for the next year, a 30% discount from the recently announced price increase.

Cygolite is unable to participate in the 11/4 night demo ride, and inquired about holding it 11/3. The board felt this was insufficient notice of the change for the membership. Bob will contact Cygolite to see if any of the nights from 12/2 to 12/4 would work.

All other current board members are willing to serve next year. A slate of nominations along with a call for volunteers will be published December 1st. Elimination of the statistician board position, and possibly replacing it with an events coordinator director was discussed. This would require a bylaws change, and no action was taken at this time.

 - The Policy has an excess accident medical limit of \$25,000 with a \$250 deductible and an accidental death benefit of \$10,000
