As a long-term goal, the board has been discussing emphasizing volunteer effort and de-emphasizing mileage accumulation, and ride participation could also be incorporated into a revised annual awards program.

The idea of a Sunday family ride was discussed again, but no formal proposal was put forth.

#### **New Business**

Monica would like to know if there is enough interest from club members to organize a weekend event at Paso Robles at the end of October. Mike believes it is better to organize an event with a lot more lead time, and then generate interest to get a good turnout. Bill will see if interest can be ascertained through an email Alert.
