Reading of the Minutes

Minutes of the 10/26/17 Board meeting were accepted.

Director Reports

President: Mike Farrell

Maya presented a written catering estimate from Citrus Café, which is attached to these minutes, for the 1/20/18 annual meeting banquet. Cost is approximately \$26 per person plus tax and gratuity. Jim moved to accept the estimate, Bill seconded, and the motion passed.

Jim reported 33 riders attended the 11/11 Carlsbad remote ride.

Dropping Sunday long+ rides was discussed, since many only have only one rider sign up. It was decided to continue to maintain the long+ ride database and print route slips for now.

The treasurer's monthly report as of 10/31/17 is attached to these minutes. Steve projects an

\$800 - \$1,100 net loss for the club for 2017, which is similar to the loss for 2016, and asked for ideas for increasing revenue. The board will need to either increase the annual dues or charge more for individual events in order to balance income with expenses.

After the exchange rate, TidyHQ will only cost \$263 for hosting the club website for the next year.
