Ideas for caterers for the 1/25/19 annual meeting banquet were discussed.

#### **Vice President: Dave Murphy**

Dave brought 5 "kits" (bicycle jerseys with matching bibs) to the meeting, which were ordered directly from China from different manufacturers. The intent is to replicate the kits being sourced from JL Velo presently, at a cost which will be both less expensive for the members and allow some profit for the club. The club makes no money from the sales through JL Velo. Fit, design, and cost were discussed. Cost ranged from \$20 to \$38 per kit. There being no great differences between the 5 sample kits, it was suggested Dave work with the vendor of his choice for the club order. It was decided to sell the kits to members for \$60, and jerseys, shorts, and bibs for \$30 each. Bill will solicit orders through an alert and on the website.

Speakers for upcoming general membership meetings were discussed. Vince suggested a coach with training tips to prepare for the June Onyx Challenge ride. Dave asked Bob if he could show pictures from his August Colorado tour at the 12/11 meeting, and Bob agreed.

Dave is working with Vince on possible remote rides from San Diego back to Irvine, and a December ride to the Mission Inn in Riverside to see the Christmas lights.
