Reading of the Minutes

Minutes of the 1/20/18 Annual meeting and 1/24/18 Board meeting were accepted.

Director Reports

President: Mike Farrell

Mimi's Café has been reserved for this year's board meetings.

The IRWD community room has been reserved for this year's general membership meetings, with Laura, Jane, and Mike listed as the contacts for the club. A key for the room must be picked up to use for the year, as opposed to the previous door code system.

The JL Velo web store for purchase of club clothing will be open from 3/3-3/15.

Club member Kent Peppard suggested it might build group comradery to embellish the jerseys in a way to distinguish different levels of riders (primarily the "blue" ride group). After discussion, the board is not in favor of this because it may not be good for club unity and will increase the cost of the club jerseys.

Laura is continuing to explore ways of making the club more welcoming to guests, with the goal of them becoming club members. One suggestion is having a couple club members greeting guests at the Deerfield Park weekend rides and introducing them to members of their selected ride group on a personal level.

There have been recent complaints about unsafe riding practices by some blue group participants, such as phone usage, ear buds, and riding 4 across. Laura suggests the club develop a set of safety guidelines to remind members before the start of the rides, as is done in another club Laura rides with.
