## **General Liability Insurance Discussion**

- General Liability Insurance renewed in October; \$949.05
  - October 15, 2018 to October 15, 2019
  - Same Provisions / Limits as 2017-2018
    - \$1M for each occurrence
    - Other coverages: Damage to rented premises, personal injury, general aggregate, products, accident medical and accidental death
- Optional addition coverages available (not purchased)
  - Add'l \$1M Liability = \$1,270
  - Auto Liability (4-5 drivers) = \$445
  - Sexual Abuse Liability = \$950
    - children
