#### **Reading of the Minutes**

Minutes of the 3/28/19 Board meeting were accepted.

#### **Director Reports**

#### **President: Marc Urias**

Marc looked at Pavilion Park as a venue for the 2020 annual meeting, but found parking to be very limited. Bob said to seat 100 guests and have a kitchen at the Woodbridge Village Association (WVA) would require the Oak/Maple/Elm meeting rooms and cost \$325. No security guard is needed at this facility when serving alcohol, because the WVA front desk person satisfies this role. Bob will see if the rooms are available for either Saturday 1/11 or 1/25.

A facility needs to be reserved for the annual holiday potluck dinner, preferably on Saturday 11/23.

The OC Bike Rally (OCBR) is scheduled for 6/29 with the OC Wheelman. Marc was contacted by the Big Bear Cycling Association (BBCA), and invited their members to attend the rally. Cross marketing our rally with BBCA's Ride Around the Bear was mentioned, but not discussed.

#### Vice President: Dave Murphy

The Tour of 5 Cities remote ride is scheduled for 4/27.

Dave is working on securing speakers for the 6/10 general membership meeting.

Dave is also coordinating sponsors to attend the Vendor Fair to be held in conjunction with the OCBR.

Dave is working on scheduling a July beach ride.

Dave reports a lack of interest for Paul Zeigler's multi-day camping tour. Dave and Paul will start an interest list for a multi-day tour using hotels. The tour will be limited to 7 participants if Amtrak is utilized for conveying the participants and their bikes.

Mike Ferrell and Paul Haussler will sag the 6/1 Onyx Challenge remote ride.

Vince will be gone from 6/15-7/13 and will need coverage for weekend ride starts whenever Paul cannot fill in.

Saturday and Sunday ride starts will change to 8:00am from 7/6 through 9/8.

Vince would like to put a "blue" ride to Seal Beach on the calendar this summer, and was assured that all 3 rides on a weekend day need not always meet at the same rest stop.

Steve reported the club had a positive cash flow month in March, but is still running a deficit for the year.

Ways to help ACC participants with fundraising were discussed. Ed suggested simply appealing to other club members to donate to the participants. Bob will draft an email and send to Bill to send out to the membership.

Bob contacted Cygolite about holding a Full Moon Fun Ride on 6/15, or sponsoring a Saturday rest stop. They have also been contacted by Dave regarding the Vendor Fair at the OCBR, and are in the process of deciding which event(s) to attend.
